

## **Important Auction Information**

### **Auction with Reserve**

The auctioneer may withdraw the goods at any time until he/she announces completion of the sale. The goods may be put up subject to the seller's confirmation or subject to a certain reserve price. At an auction with reserve the seller has the right to reject or confirm a bid. This does not automatically give the seller, or anyone acting on the seller's behalf, the right to bid. It is not required to announce the reserve price when it is met.

### **Absolute Auction**

The item will change ownership regardless of price. ALL auctions in Louisiana are absolute unless otherwise stated.

### **As Is**

There is no guarantee or warranty for the item.

### **Buyer's Premium**

A fee charged to buyers at some auctions. The buyer's premium is a percentage that is added to the last or final bid amount to determine the actual selling price. At all auctions that include a buyer's premium, the amount of the buyer's premium shall be announced at the beginning of the auction and a written notice of this information shall be conspicuously displayed or distributed to the public at the auction site.

### **Consignor**

The person or authorized agent or entity that consigns goods to an auctioneer. The consignor is usually the seller.

### **Consignee**

The auctioneer, apprentice auctioneer, or auction firm to whom goods are entrusted by another (consignor) for sale at auction.

### **Auction Contract or Agreement**

The agreement between the auction firm or the auctioneer and the seller (or his/her agent) where the parties agree to the offering of certain personal or real property for sale at auction as set forth in the contract. All auction contracts or agreements with a value over \$500 are required by law to be written and must contain the terms and conditions upon which the auctioneer or auction firm received the property for sale. There must be a signed auction contract or agreement before any advertising is begun. A signed copy of the contract or agreement must be provided to the owner and the auctioneer or auction firm must retain a copy.

### **Subject to Confirmation**

The auctioneer will contact the seller with the high bid and the seller will determine whether to accept or decline the sale.

### **Additional Info:**

Licensees may **not** bid on their own behalf, but may bid on behalf of the consignor to protect the consignor.

Once the hammer falls, the sale is final.

### **East Baton Rouge Parish Auctions**

### **Internet Auctions**

**Timed** internet auctions are not regulated by the Louisiana Auctioneers Licensing Board.

### **Manufactured Home Sales**

If you sell manufactured homes at auction that have a HUD sticker (regardless of the number sold), you must be licensed by the LA Manufactured Housing Commission

*b. Louisiana manufacturers and dealers of mobile homes, motor homes, travel trailers, or any recreational vehicles shall comply with all state and federal safety standards and perform all safety tests on mobile homes, motor homes, travel trailers, or any recreational vehicles using liquefied petroleum gas.*

*c. Upon delivery of a mobile home, motor home, travel trailer, or any other recreational vehicle, new or used, the required installation report, and inspection and testing of any liquefied petroleum gas system and appliances shall be performed by the dealer or any entity performing functions as a dealer, using liquefied petroleum gas in the system. An installation report properly completed and signed by the customer or his/her authorized representative must be sent to the director of the Liquefied Petroleum Gas Commission verifying that the tests were performed and that the test was eye witnessed by the customer or his/her authorized representative.*

*d. The mobile home or recreational vehicle dealer or entity performing functions as a dealer must have a permit with this commission and is responsible to this commission to make the required installation report, perform the required inspection and safety tests or make arrangements for it to be made by a qualified permit holder.*

All mobile homes, motor homes, etc. that have a gas line must be tested prior to delivery. You have the option of getting someone in your organization trained to test these units or you must use someone who is already qualified.

**Real Estate Auctions**

In Louisiana, it is not required to be a licensed realtor in order to auction real estate if you are a licensed auctioneer; however, it is necessary to be sure you are meeting the requirements issued by the Louisiana Real Estate Commission. [www.lrec.state.la.us](http://www.lrec.state.la.us) This board highly recommends you have a realtor involved in the process.

**Titled Vehicle Auctions**

Auctioneers or auction houses who are not engaged in the auction of used motor vehicles as the principal part of their business, including but not limited to the following auctions: estate auctions, bankruptcy auctions, farm equipment auctions, or government auctions are exempt from holding a separate license.
